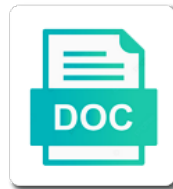
Temporary and self-employed persons may perform the same duties as permanent employees but are not considered employees for purposes of unemployment insurance and job termination benefits.
